## **Play Station Participant Agreement Form**

### **Enrollment & Fees:**

Reservations must be made 24 hours in advance to ensure space in the Play Station.

Call 949-824-5045 to make a reservation. \* Drop-ins on a space available basis.

Fees are \$3 per hour for dependents of UCI students and \$4 for dependents of non-student ARC members.

A Play Pass, good for 10 hours of babysitting service, can be purchased at the Campus Recreation Services and Fit Well desk. The fees are \$25 for dependents of UCI students and \$35 for dependents of non-student ARC members. All fees must be paid at the Campus Recreation Services and Fit Well desks. The Play Station staff cannot accept payment for services. Receipt or Play Pass should be taken to the Play Station and shown for proof of purchase for the babysitting service. If a Play Pass is purchased, it will be kept in the Play Station and punched as you use it.

**\* Cancellations or changes to reservations must take place four hours prior to reservation or you will be charged for the time reserved.**

### **Rules:**

- Participants must fall within the range of 6mths- 12 years of age.  
Parents must remain in the ARC (at no time are you allowed to leave the building, including ARC fields, tennis and basketball courts) while the child is under the supervision of the Play Station staff. Parent/Guardian's who leave the facility while their child is in the Play Station will lose the right to use the service permanently.
- Parents/Guardians must sign in with the Play Station attendant and proceed to record the current date, time, name of child, age of child and parent's anticipated location within the facility.  
No other person may pick up the child except the parent/guardian who signed in the child without written authorization.
- Parents/Guardians must sign out when picking up the child at the Fit Well Services desk.
- For the health and safety of all children and staff, sick children are not permitted in the Play Station. Staff has the right to refuse any child from entering the room due to suspected illness (this includes: chicken pox, diarrhea or vomiting, fever, running nose, pink eye, conjunctivitis, rashes and the flu). Parents will be paged if their child becomes ill while under supervision.
- Food is not permitted in the Play Station; however, a leak proof cup labeled with your child's name is allowed.
- Play Station babysitters cannot at any time administer medication, change diapers, feed children, administer bottle feedings etc. Parents/Guardians will be paged if their child needs his or her diaper changed during babysitting service.
- Parents will also be paged in the event an upset child cannot be calmed after 15 min in the Play Station.
- Children participating in the babysitting service must wear socks at all times while within the Play Station (Socks are available for purchase in the event your child does not have socks). If a child does not walk, they will be kept in the enclosed infant area.
- No outside toys are permitted within the Play Station.
- Children whose behavior is unruly, negatively affecting other children, or threatening to the safety of the group may be asked to leave. Parents will be contacted to remove their child. If behavior is chronic, the child may lose eligibility to participate in the Play Station.
- Children should be escorted to and from the Play Station; staff are not allowed to bring child outside the Play Station to meet parents at some other location within the facility.
- Children are not permitted inside locker rooms, weight rooms, activity rooms, gym, etc.

**\*\* If an evacuation of the facility were necessary during babysitting hours please meet near the outside stairwell closest to the Play Station.\*\***

**Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**Acknowledgment of Understanding:** I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and **understand that I am giving up substantial rights, including my right to sue.** I acknowledge that I am signing the agreement freely and voluntarily, and **intend by my signature to be a complete and unconditional release of all liability** to the greatest extent allowed by law.
